### **Format of board /special resolution for striking off of ...**

The Company Secretary informed the Board that the company is required to obtain secretarial audit report(s) from a Company Secretary in practice as per Section 204 of the Companies Act, 2013 since our company is a public company having a paid-up share capital of more than fifty crore rupees, and hence a Secretarial Auditor shall be appointed.

### **Board Resolution for Appointment of Secretarial Auditor ...**

As per the provisions of section 180(1)(a) of the Companies Act, 2013 the Board of Directors of a company can sell, lease or otherwise dispose of the whole or substantially the whole of the undertaking of the company or where the company owns more than one undertaking, of the whole or substantially the whole of any of such undertakings, only with the consent of the company by a special resolution.

### **Board Resolution to Sell, Lease or Otherwise Dispose of ...**

In South Africa, company resolutions are governed by the Companies Act 71 of 2008. According to the act, company resolutions: must be sequentially numbered and dated; and; are effective from the date of the resolution - unless stated otherwise in the resolution. For a resolution to pass, members of the board have to vote on the proposed ...
