You can provide financial relief to your patients if you wish, but you should only do so in accordance with a uniform hardship policy. As a general rule, the practice should not routinely waive co-pays or deductibles, or offer discounts based on a patient's statement that the patient is suffering from financial hardship.

Fill out a Request for Hardship Determination (VA Form 10-10HS). Download VA Form 10-10HS (PDF) Write a letter explaining why you're requesting a hardship determination. The letter should describe the financial issues that make it hard for you to pay your copays. Submit your completed form and letter to us.

For example, if a qualifying relative has a medical condition that alone does not rise to the level of extreme hardship, the combination of that hardship and the common consequences of inferior medical services, economic detriment, or readjusting to life in another country may cumulatively cause extreme emotional or financial hardship for the qualifying relative when considering the totality of the circumstances.

An application for a financial hardship for medical expenses and fees must be made in accordance with Integritas' policy entitled "Financial Hardship Policy". Applicants may request and complete a Financial Hardship Application Form.

Financial Hardship Policy new - Integritas

Despite financial hardship, network providers may not waive or reduce copayments, co-insurance, or deductibles. If true financial hardship exists, providers may reduce or waive their charges (but not copays/deductibles) provided financial hardship has been clearly established and supporting documentation is maintained in the health care record.
