Thirteen of the species studied were birds, including the Cerulean Warbler, Northern Aplomado Falcon, and Gunnison Sage-Grouse. They also found that lands owned by states and by non-governmental organizations performed better than private land, with 4.6 percent and 4.5 percent of endangered habitat lost, respectively, over the past three decades.
